



Pittsylvania County Schools Device Loan and Use Agreement

Through the High School Student Device Initiative, it is the goal of Pittsylvania County Schools (“PCS”) to provide students with personalized online learning opportunities that extend beyond the classroom and school building, and provide routines and structures to help students stay engaged in their learning. In accepting the Chromebook, its charger, and case (collectively, the “Device”) loaned under this Agreement, students and parents agree as follows:

1. The Device is owned by and is the property of PCS.
2. The Device shall be returned by the student and/or parent to PCS immediately upon the earliest of the following:
 - The withdrawal, transfer, graduation, or other separation of the student from PCS;
 - The end of the current academic school year; or
 - The request of PCS, in its sole discretion.
3. The parent assumes all risk of loss (by theft or otherwise), destruction and/or damage (including as a result of the misuse) of or to the Device. If damaged, lost, stolen, or not returned as required by this Agreement, the parent agrees to pay for the cost of repair or replacement of the Device.
4. The Device shall be used as follows:
 - Devices may be used for educational purposes only and shall be used solely by the student. The Device shall not be used for personal, commercial, or business use.
 - Device use is governed by the Pittsylvania County Schools [Acceptable Use Policy](#).
 - The student and parent assume full responsibility for basic care and security of the Device both on and off school grounds.
 - Upon request, the student and parent shall make the Device available to PCS personnel for inspection, verification, inventory, screening/monitoring, technical updates/troubleshooting or for any other purpose in PCS’s sole discretion.
 - There is no expectation of privacy in or to the Device. PCS may access, monitor, and archive use of the Device, including (but not limited to) use of the PCS information and technology system, internet usage/history, downloads, messages, applications, and emails at any time and without prior notice.
 - The Device shall be kept away from liquids and extreme temperatures, and the Device surfaces shall not be personalized or defaced in any way.
 - PCS identification and other labels shall not be removed from or altered on the Device.
 - The Device configuration and settings shall not be altered or changed nor shall any software/hardware, be installed, uninstalled, deleted, or altered.
 - Device malfunctions, problems, and damage as well as a lost or stolen Device shall be reported to PCS immediately.

I have read and understand the Pittsylvania County Schools’ Device Loan and Use Agreement as set forth above and agree to its terms. I understand that any violation of my obligations under this Agreement may result in the loss of the privilege of having a Device issued to me or my student.
